



We welcome and honor the voice of our community, their engagement, and self-determination in shaping the direction of our work.





We embrace and leverage collective strengths, diverse perspectives, talents, and resources with internal and external stakeholders to be more effective and achieve common goals.



 - By March 2026, align with CHIP, convene stakeholders focusing on all aspects of whole person care to develop a 10-year plan to increase access to care, including infrastructure, to address current and future county needs

 - Secured buy-in/Support from at least 90% of stakeholder organizations within Adams County on our 10-year Health Infrastrure plan.

 - Estimate Completion Date Q1 2026


