### **4. Approval of previous meeting minutes, November 16**

### **6. \*FY24 Final Budget Approval**

The 2024 Health Department budget was adopted by the Board of County Commissioners on December 5<sup>th</sup>, 2023. Since that time the Health Department has received additional grants and funding. The FY24 adopted budget includes general fund revenue of approximately \$12M, an increase over the \$10M from FY23 to balance out the increased cost of in personal expenditures such as the annual employee investment and employer-paid health insurance premiums. Additionally, the FY24 does not include any capital improvement projects as discussed by County Manger Noel Barnal at the November meeting.

Jeremiah Lindmann, motioned to approve the 2024 Adams County Health Department budget, seconded by Dr. Lisa Winkler. All in favor and the motion passed unanimously.

*Dr. Weidenbach, Adam Anderson, and Dr. Albanese provided an update on a recent multi-jurisdictional measles investigation with involvement from both the Communicable Disease Epidemiology Program and from the Nursing Division-Immunization Program who assisted with the contact investigation related to exposures happening at Children's Hospital.*

*Dr. Weidenbach provided a verbal update to the BOH members regarding ACHD's 2024 Capital Improvement Project (CIP) Request. The Board gave general direction to Dr. Weidenbach to draft a letter from the BOH to the Board of County Commissioners to advocate for the department's CIP request and given County Manager's offer to reconsider after the special legislative session. The letter is to advocate for new buildings and space for health department operations, addressing gaps in services within the County, and to request ACHD representation on the County's CIP Committee. Dr. Weidenbach proposed a timeline for the development and delivery of the letter to the Commissioners based on their holiday break and public hearing schedule. The Board supported this plan and timeline.*
