Why are we here? Level-Setting

- ACHD BOH has indicated an interest in climate and environmental justice issues, which are very prevalent in Adams County.
- BOH & programming being aligned = more political power
- Informal requests from community for Health Dept. to get more involved in EJ



A few examples of community messages

- The community identified the need to build better relationships between governments and community to help foster trust and willingness.
- A wish list to address climate impacts and pollution, such as resilient and healthy homes, tree planting, cumulative impact assessment, and transit solutions.
- The community also identified a desire for government partners to give them agency for themselves when it comes to decisionmaking in their communities.

Quick Background on Environmental Justice

- "Environmental justice is the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies (The EPA). This goal will be achieved when everyone enjoys:
 - The same degree of protection from environmental health hazards, and
 - Equal access to the decision-making process to have a healthy environment in which to live, learn, and work."



Environmental Justice in Colorado

- Environmental Justice Act passed in 2021 (HB21-1266)
 - Creation of the Environmental Justice Action Task Force and Task Force Recommendations
 - Created Environmental Justice Advisory Board
 - Created initial definition of Disproportionately Impacted Community
 - Created Environmental Justice Ombudsperson within CDPHE
 - Required Environmental Justice Summaries by permit applicants for new and modified sources of emissions
 - Encourages additional community engagement with DIC communities
- Colorado EnviroScreen



What's Happening Currently

Rulemakings

- Oil & Gas cumulative impact rulemaking (finished Oct. 2024)
- Landfill Greenhouse Gas monitoring and control requirements (July 2025)
- Ozone State Implementation Plan (SIP) rulemaking revision (Nov. 2025)
- Identifying Priority Air Toxics (Jan, 2025), reporting and monitoring priority air toxics, setting health-based values (Jan. 2025-late 2026)

Suncor

- Title V Permits under consideration; Plant 2
- Active lawsuit pending from Earthjustice (on behalf of GreenLatinos, 350 Colorado, Sierra Club)
- Hiring and onboarding of legislatively required Petroleum Refinery Expert

- Environmental Equity and Cumulative Impact Analyses (EECIAs)
- Mobile Home Park Testing Results
- Enviro-Gov-O&Gas legislative deal on multi-modal funding
