RESOLUTION APPROVING ADAMS COUNTY BOARD OF HEALTH'S PURPOSE STATEMENT AND 2025-2026 GOALS
Resolution No. 2025 – 001

WHEREAS, pursuant to 6 CCR 1014-7, accountability, organizational performance management and quality improvement are foundational public health capabilities and essential to creating a public health system that provides high-quality public health services; and,

WHEREAS, strategic planning serves as a foundational anchor for organizations, providing essential guidance and clarity in achieving their objectives; and,

WHEREAS, as a part of their performance management, quality improvement, and strategic planning work, the Adams County Board of Health began developing their Purpose Statement and 2025-2026 Goals at their August 2024 Board of Health Retreat and have continued working to finalize drafts for full Board of Health consideration; and,

WHEREAS, the Purpose Statement and 2025-2026 Goals will establish a clear and unified direction for the work and decision-making of the Adams County Board of Health, guiding both internal and external stakeholders in understanding the Board of Health's core goals, beliefs and intentions.

NOW, THEREFORE BE IT RESOLVED by the Adams County Board of Health that, after review and consideration of draft language presented, the following Adams County Board of Health Purpose Statement and 2025-2026 Goals are hereby approved:

- **Adams County Board of Health Purpose Statement:** Through leadership, governance, and advocacy, we ensure the Adams County Health Department advances the delivery of essential and emerging public health services in innovative and impactful ways.
- **Adams County Board of Health 2025-2026 Goals:**
 - **COLLABORATION.** By August 2026, the Board of Health will increase its engagement with ACHD staff and community members to strengthen collaborative relationships and further understand current public and environmental health needs, priorities, and opportunities to inform their decision-making.
 - **MEMBER DEVELOPMENT.** By August 2026, the Board of Health will strengthen its understanding of its roles and collaboratively design strategies to integrate this knowledge into actionable initiatives that advance the Board of Health's and Health Department's Purpose Statements.
 - **PARTNERSHIPS.** By August, 2026, the Board of Health will collaborate with other local boards of health to gain insights into shared challenges and successes, identify innovative practices, and enhance its decision-making process.
