RESOLUTION APPOINTING BOARD OF HEALTH PRESIDENT

Resolution No. 2025-008

WHEREAS, the Adams County Board of Health ("Board of Health") serves as the governing body of the Adams County Health Department ("ACHD"); and,

WHEREAS, pursuant to C.R.S. §25-1-508, at its organizational meeting the Board of Health shall elect from its members a President and such other officers as it determines necessary; and,

WHEREAS, the President of the Board of Health is charged with presiding over meetings, providing leadership and guidance to the Board of Health, and carrying out the duties of the office consistent with the Board of Health Bylaws and applicable law; and,

WHEREAS, the Board of Health recognizes the importance of the President's role in ensuring that the Board of Health fulfills its statutory responsibilities, including, but not limited to, approving local public health plans, developing public health policies, and supervising the Public Health Director in accordance with C.R.S. §25-1-508; and,

WHEREAS, pursuant to the Adams County Board of Health Bylaws, the President shall serve terms of one (1) year and shall serve no more than two (2) consecutive one (1) year terms; and,

WHEREAS, on December 19, 2024, the Board of Health considered the qualifications and interest of its members and elected Dr. Deidre Gilliam, DNP, RN, PHN to serve in this leadership capacity.

NOW, THEREFORE, BE IT RESOLVED, that the Adams County Board of Health hereby codifies their election of Dr. Dierdre Gilliam, DNP, RN, PHN, as President of the Adams County Board of Health, effective December 19, 2024, for a one-year term.
