**RESOLUTION APPOINTING BOARD OF HEALTH VICE PRESIDENT**

**Resolution No. 2025-009**

**WHEREAS**, the Adams County Board of Health (“Board of Health”) serves as the governing body of the Adams County Health Department (“ACHD”); and,

**WHEREAS**, pursuant to C.R.S. §25-1-508, at its organizational meeting the Board of Health shall elect from its members a President and such other officers as it determines necessary; and,

**WHEREAS**, the Board of Health determined that it was necessary to create the officer role of Vice President; and,

**WHEREAS**, pursuant to the Board of Health Bylaws, the Vice President is charged with acting as President in the absence of the Board of Health President, including, but not limited to, presiding over meetings, providing leadership and guidance to the Board of Health, and carrying out the duties of the office consistent with the Board of Health Bylaws and applicable law; and,

**WHEREAS**, pursuant to the Adams County Board of Health Bylaws, the Vice President shall serve at the pleasure of the Board of Health for an initial term of one (1) year, and shall serve no more than two (2) consecutive one (1) year terms; and,

**WHEREAS**, on December 19, 2024, the Board of Health considered the qualifications and interest of its members and elected Jeremiah Lindemann to serve in this leadership capacity.

**NOW, THEREFORE, BE IT RESOLVED**, that the Adams County Board of Health hereby codifies their election of Jeremiah Lindemann as Vice President of the Adams County Board of Health, effective December 19, 2024, for a one-year term.
