RESOLUTION APPOINTING PUBLIC HEALTH DIRECTOR

Resolution No. 2025-007

WHEREAS, the Adams County Board of Health ("Board of Health") serves as the governing body of the Adams County Health Department ("ACHD"); and,

WHEREAS, pursuant to C.R.S. §25-1-508, the Board of Health has the power and duty to select a Public Health Director to serve as the administrative and executive head of ACHD; and,

WHEREAS, pursuant to C.R.S. §25-1-508, the Public Health Director must possess such minimum qualifications as prescribed by the state board and must reflect the resources and needs of Adams County; and,

WHEREAS, the Board of Health recognizes the importance of the statutory duties of the Public Health Director, which include, but are not limited to, directing the resources of ACHD, enforcing public health laws and regulations, hiring and supervising ACHD employees, and carrying out public health programs and services; and,

WHEREAS, the Board of Health undertook a process to identify, review, and select a qualified individual to serve as the Public Health Director of ACHD; and,

WHEREAS, on September 1, 2022, the Board of Health selected Dr. Kelly Weidenbach, DrPH, MPH, to serve as the Public Health Director of the Adams County Health Department.

NOW, THEREFORE, BE IT RESOLVED, that the Adams County Board of Health hereby codifies its appointment of Dr. Kelly Weidenbach, DrPH, MPH, as the Public Health Director of the Adams County Health Department, effective September 1, 2022.
