**RESOLUTION ADOPTING ADAMS COUNTY HEALTH DEPARTMENT 2026 BUDGET**

**Resolution No. 2025-014**

**WHEREAS**, pursuant to C.R.S. §25-1-511 and C.R.S. §29-1-103, the Adams County Board of Health (“Board of Health”) has the power and duty to estimate the total cost of maintaining the Adams County Health Department (“ACHD”) for the ensuing fiscal year and to submit that information in the form of a budget to the Board of County Commissioners; and

**WHEREAS**, the ACHD Executive Director, Public Health Performance & Business Excellence Division Director, and staff prepared the proposed 2026 ACHD budget and which was presented to the Board of Health at their June 26, 2025 meeting; and

**WHEREAS**, the 2026 ACHD proposed budget reflects a fiscally responsible approach to sustaining the Department’s essential community services and supports key investments in ACHD’s Community Health Improvement Plan, Strategic Plan, and their identified priority areas.

**NOW, THEREFORE, BE IT RESOLVED**, by the Adams County Board of Health that the 2026 ACHD proposed budget, presented to the Board of Health on December 18, 2025, is hereby approved.
