#### **RESOLUTION ADOPTING 2026 FEE SCHEDULE FOR ENVIRONMENTAL HEALTH SERVICES**

#### Resolution No. 2025-013

**WHEREAS**, pursuant to C.R.S. §25-1-508 and C.R.S. §25-10-107, the Adams County Board of Health ("Board of Health") has the authority and duty to provide environmental health services and to assess fees to offset the actual, direct cost of such services; and

**WHEREAS**, the Board of Health adopted Adams County Health Department ("ACHD") Fee Schedule for Environmental Health Services on October 20, 2022; and

**WHEREAS**, ACHD conducts regular environmental health fee assessments to ensure that the fees assessed for environmental health services continue to reflect the actual, direct costs of providing such services; and

**WHEREAS**, ACHD conducted a 2025 environmental health fee assessment and, based on that assessment, proposed the 2026 Fee Schedule for Environmental Health Services; and

**WHEREAS**, the Board of Health considered the proposed 2026 Fee Schedule for Environmental Health Services at Study Session on October 16, 2025, and set the item for a Public Hearing; and

**WHEREAS**, the Board of Health held a Public Hearing to consider adoption of the 2026 Fee Schedule for Environmental Health Services on November 20, 2025.

**NOW, THEREFORE BE IT RESOLVED**, that the Adams County Board of Health, after proper notice and a Public Hearing, and finding that fees set forth therein are fair, reasonable, and reflective of the actual, direct cost of providing such services, hereby adopts 2026 Fee Schedule for Environmental Health Services, effective December 1, 2025.
