### RESOLUTION APPOINTING BOARD OF HEALTH PUBLIC HEALTH DIRECTOR ANNUAL REVIEW COMMITTEE MEMBERS

#### Resolution No. 2026-005

**WHEREAS**, the Adams County Board of Health ("Board of Health") serves as the governing body of the Adams County Health Department ("ACHD"); and

**WHEREAS**, under Colorado Revised Statutes ("C.R.S.") § 25-1-502, ACHD's Public Health Director serves as the administrative and executive head of ACHD; and

**WHEREAS**, under C.R.S. § 25-1-508, the Board of Health is responsible for selecting the Public Health Director, who serves at the pleasure of the Board; and

**WHEREAS**, C.R.S. § 25-1-508 further authorizes the Board of Health to determine the general policies to be followed by the Public Health Director; and

**WHEREAS**, the Board of Health has implemented ACHD Operational Directive: Public Health Director Annual Review, detailing the formal policy and process for the annual performance evaluation of the Public Health Director; and

**WHEREAS**, pursuant to ACHD Operational Directive: Public Health Director Annual Review, the Board of Health must appoint two (2) Board members to serve on the Public Health Director Review Committee.


