RESOLUTION APPOINTING BOARD OF HEALTH VICE PRESIDENT

Resolution No. 2026-004

WHEREAS, the Adams County Board of Health (“Board of Health”) serves as the governing body of the Adams County Health Department (“ACHD”); and

WHEREAS, pursuant to Colorado Revised Statute (“C.R.S.”) § 25-1-508, the Board of Health shall elect from among its members a President and such other officers as it deems necessary; and

WHEREAS, the Board of Health has determined that it is necessary to establish the officer position of Vice President; and

WHEREAS, pursuant to the Board of Health Bylaws, the Vice President is charged with acting as President in the absence of the Board of Health President, including, but not limited to, presiding over meetings, providing leadership and guidance to the Board of Health, and carrying out the duties of the office consistent with the Board of Health Bylaws and applicable law; and,

WHEREAS, pursuant to the Adams County Board of Health Bylaws, the Vice President shall serve at the pleasure of the Board of Health for an initial term of one (1) year and may serve no more than two (2) consecutive one-year terms; and

WHEREAS, the Board of Health elected Jeremiah Lindemann to serve as Board Vice President on December 19, 2025; and

WHEREAS, Jeremiah Lindemann has successfully served in that capacity during the initial one-year term.

NOW, THEREFORE, BE IT RESOLVED, that the Adams County Board of Health, after considering the qualifications and interest of its members, reelects Jeremiah Lindemann to serve as Vice President of the Adams County Board of Health, effective February 19, 2026, for one (1) additional one-year term.
