RESOLUTION ADOPTING ADAMS COUNTY HEALTH DEPARTMENT 2027 PROPOSED BUDGET

Resolution No. 2026-008

WHEREAS, pursuant to C.R.S. §25-1-511, the Adams County Board of Health (“Board of Health”) has the power and duty to estimate the total cost of maintaining the Adams County Health Department (“ACHD”) for the ensuing fiscal year and to submit that information in the form of a budget to the Board of County Commissioners; and

WHEREAS, the ACHD Executive Director and staff prepared the proposed 2027 ACHD budget and presented said budget to the Board of Health at their June 18, 2026, meeting; and

WHEREAS, the 2027 ACHD proposed budget reflects a fiscally responsible approach to sustaining the Department’s essential community services and supports key investments in ACHD’s Community Health Improvement Plan, Strategic Plan, and their identified priority areas.

NOW, THEREFORE, BE IT RESOLVED, by the Adams County Board of Health that the 2027 ACHD proposed budget is hereby approved, and ACHD staff are directed to submit the approved proposed budget to the Adams County Board of County Commissioners for its consideration and approval in accordance with applicable law and County policy.
